The following letter is submitted in response to the requested permit addendum for the discharge of wastes generated from shop towel washing. The shop towels are associated with submarine maintenance activities. Based on an inspection of the Spruce Barge pretreatment system, previously submitted procedural information and analytical data, these wastes are acceptable for sanitary sewer discharge. The NAVALKLEEN microbial addition must be utilized as per the process description dated August 17, 2000.

Please provide this office with written prior notification in the event any system, operational, or discharge changes are planned.

While these wastes are approved for immediate discharge, formal permit reference to this pretreatment system will added to the upcoming July 2001 permit reissuance.
